I also assume full responsibility for damages done by me, my family, my livestock, or my property.

In consideration of the agreement of the Flying E Ranch/Wickenburg Saddle Club to permit me to utilize their facilities I do hereby for myself, my heirs, personal representatives and assigns, absolve, release and discharge the Wickenburg Saddle Club, it's directors, officers and members from any and all claims, demands and causes of action for injuries which I may receive by reason of any equine, regardless of weather such injuries may occur while I am on or off such equine.

By being on the grounds of Flying E Ranch and participating in events of the Wickenburg Saddle Club hosted by Flying E Ranch, I hereby give the Flying E Ranch/Wickenburg Saddle Club permission to film and/or photograph myself or my child/children for the purpose of producing promotional materials, newspaper articles, public advertisements of awards from sponsors. I also understand that the photos may be posted on the Wickenburg Saddle Club Facebook and/or web page. I also release the Wickenburg Saddle Club, its directors, employees, consultants, agents, and photographers from all liability arising from the use of the photos, video, and/or photography of my child/children/horses/family. I also understand and agree that no compensation will be paid to me, my child/children, or my family for participating in photography.

Property/Activity Rules:

1. All dogs MUST be leashed on property.
2. No Stallions are allowed on property.
3. No riding double or bareback.
4. Proper riding boots and attire are mandatory for participation in any mounted Saddle Club activity.
5. No loping in the parking lot! Horses are not to be rode any faster than a walk or a slow jog outside of the arena/round pen.
6. Keep horses in the designated horse area and not in the pedestrian/spectator area.
7. Do not tie horses to fences or trees, please only tie to designated tie areas.
8. No unnecessary or excessive schooling of horses allowed while on Saddle Club Property. If deemed inappropriate/abusive, you will be disqualified for the day. No Exceptions.
9. Please pick up after yourselves. If you see trash laying around, please pick up and put in provided receptacles.
10. All small children are to be supervised by an adult at all times while on Flying E Ranch property. Babysitters are not provided.
11. EVENT FIELD JUDGE'S DECISION WILL BE FINAL.
